






### 19 mm mesh net to prevent the intrusion of birds of the same type as sparrow





#### ECOPIC® ADVICE :

- Using a drawing, calculate the number of screws and netbolts you need.
  - Check the characteristics of the ordered net (with the label attached to the net).
  - Spread out the net, using the corner marks (label, etc.), the nets have a square mesh.
- For 10x100 m nets, take one corner (label, etc.), then measure 10 meters on the edge, if the other corner is reached the net is ready to be put into place to make any necessary cuts.
- Otherwise, for sizes larger than 10 meters, start again from the other side.
